This program works to change federal, state, and local government policy and support communities impacted by existing and proposed energy extraction, to raise awareness about unconventional shale oil and gas and hydraulic fracturing (aka fracking) and to reduce the destructive impacts of all forms of energy extraction.

4b (Code:) (Expenses \$ 566,278. including grants of \$ 9,905.) (Revenue \$) The Mining Program includes U.S. mining reform efforts, international mining work, and the No Dirty Gold campaign. This program focuses on legislative and regulatory strategies on campaigns to protect specific places from mining impacts, and on market strategies and efforts to involve consumers and jewelers in placing pressure on mining companies to improve mining practices and to protect communities and the environment in the U.S. and overseas.
