This program works to change federal, state and local government policy and to support communities impacted by existing and proposed energy extraction, to raise awareness about unconventional shale oil and gas and hydraulic fracturing (fracking) and to reduce the destructive impacts of all forms of energy extraction.

4b (Code:) (Expenses \$ 524,913. including grants of \$ 10,466.) (Revenue \$) The Mining Program includes US mining reform efforts, international mining work, oceans mining work, and the No Dirty Gold campaign. This program focuses on legislative, regulatory and legal strategies to protect specific places from mining impacts, and on market strategies and efforts to involve purchasers and customers of mined minerals to place pressure on mining companies to improve practices, and to protect communities and the environment from the impacts of mining.
